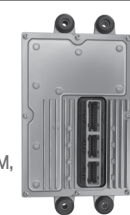

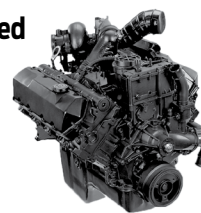

- IRF must maintain at least one service bay and be open to the public.
- Fleet must maintain at least five (5) commercial vehicles and service the fleet in an in-house Repair Facility. Dealer-performed service does not qualify.
- Limited time offers. Offers may be cancelled at any time without notice (except in Quebec).
- Ford Motor Company of Canada, Limited reserves the right to reject claims it deems to be invalid at its sole discretion.
- Dealers may NOT complete rebate forms on behalf of customers. All rebate claims must come directly from IRFs (installers) and Fleets. Rebate claims submitted by Dealers will be automatically rejected.
- All rebate program claims are subject to the terms located on this rebate flyer.
- Any notifications regarding your rebate status will be sent to you via USPS or email. A Rebate notification letter will provide reason(s) for an unaccepted status. The letter will provide reason(s) as to why the claim(s) have been rejected and allow the opportunity to resubmit within the established timeframe. ## 2017 Ford of Canada Independent Repair Facility/ Fleet Offers:

- Qualified independent auto repair facilities and fleets are entitled to the ten (10) rebates offered in this program.
- Offers may be redeemed up to six (6) times during the program period, except for Diesel Engine Assemblies and Diesel Fuel Injectors, which are unlimited.
- Purchase invoice and rebate form are required. Repair order may be requested and required in order to process the claim.

- 2. Fax to:** (877) 298-5761. Rebate request must be received by **September 30, 2017**. Purchase period must be between **May 1 – August 31, 2017** to be eligible.

To be eligible for the rebate, the purchase must be made from the following approved parts: Remanufactured Genuine Ford 6.0L or 7.3L Diesel Engine Assembly, Genuine Ford Diesel Fuel Injector Control Module (FICM), Genuine Ford 6.0L Diesel EGR Cooler, or any of the following Motorcraft® parts: Diesel Glow Plugs, 6.0L Diesel Fuel Injector, 7.3L Diesel Fuel Injector, Diesel Oil Filters or Diesel Fuel Filters – 6.0L, 6.4L, 6.7L, 7.3L, Diesel Anti-Gel Additive or Diesel Cetane Additive. The purchase must take place between 05/01/17 and 08/31/17 (the "Rebate Program Period") to be eligible for the rebate. Purchase invoice and completed rebate form are required. Rebate form must be submitted by IRF/Fleet Repair Facility. Purchase invoice date and sale date must fall within Rebate Program Period. Rebate form must be completed in full, legible and submitted online or postmarked by September 30, 2017 along with supporting documentation. Product must be purchased from a Ford of Canada Dealership. Non-Ford automotive OE Dealerships are eligible if they do not share ownership (private, public, whole, part) with a Ford or Ford Lincoln Dealership. Open to legal residents of Canada only. All Ford and Ford Lincoln Dealers and employees are ineligible. Handwritten purchase invoices will not be accepted. Retain a copy of rebate form and original invoice for your records in the event backup documentation is requested. Rebate cheque will be issued 6 to 8 weeks from receipt and validation of rebate and proof of purchase. Cheque will be payable to the business name.
